The immediate attention of the Assistant Directors working in the state is invited to the captioned subject. They are informed that the Development Commissioner for Handlooms, Government of India is contemplating a scheme of sanctioning common facility centers for the benefit of Handloom weavers with a view to provide pre loom , post loom, computer, Internet, and Marketing Facilities at one point, with an out lay of Rs 50,00,000-00.

The Assistant Directors are therefore requested to examine the availability of vacant site either with the local Primary Weaver's Cooperative Societies/Grama Panchayat and propose common facility centers for about 250 active Handloom Weaver households, where ever such facilities are not available. This proposal is applicable to existing clusters who have got funds for constructions, pooling funds from other components and also the areas /Primary Weavers Cooperative Societies who were not sanctioned cluster programme under CHDS.

They are further instructed to submit the proposals along with the following.

1. Name of Weavers Cooperative Society (Implementing Agency)/Clusters.
2. No of Looms
3. Members/Weavers beneficiaries list,
4. Details of vacant site available,
5. Willingness of the implementing agency[Resolution],
6. Financial particulars of the implementing agency for the last [3]financial years,
7. Plans and estimates prepared by licensed Engineer.
8. Approval of the local Grama Panchayat/ Municipality.
9. Undertaking of the implementing agency to extend the services of Common facility centre to all the weavers unconditionally.

They are further informed that if suitable vacant land is not readily available, the vacant place available on the existing societies building may also be considered for setting up of the common facility center provided it is suitable for the same. Further it is informed that the Development
