O R D E R:-

The Government of Andhra Pradesh have agreed to the recommendations of the Group of Ministers and issued orders in the reference 1st read above.

2. In the references 2nd and 3rd read above, Government have issued orders for consideration of Loan Waiver Scheme and instructed to implement the scheme. Further, the State Level Committee in its meetings held on 08-11-2010, 13-12-2010 and 11-01-2011 has recommended for sanction of an amount of Rs.16,67,95,443/- to State Government towards 75% waiver of individual weaver loans under Artisan Credit Card (A.C.C.) Prime Minister's Rozgar Yojana (PMRY), Rajiv Yuva Shakti (RYS) sanctioned by Commercial and other Banks.

3. In the reference 4th read above, the Government have decided to agree to reimburse 100% of the outstanding Principal only, by the State Government and accordingly issued orders for making certain amendment to the orders issued in the reference 3rd read above.

4. In the reference 5th read above, orders were issued, sanctioning an amount of Rs.16,67,95,443/- towards waiver of individual loans of handloom weavers under Artisan Credit Card (A.C.C.) Prime Minister's Rozgar Yojana (PMRY) Rajiv Yuva Shakti (RYS) payable to Commercial and other Banks from the Budget Provision 2010-11 and the Commissioner of Handlooms, Textiles & Apparel Export Parks, Hyderabad was authorized to draw an amount of Rs.16,67,95,443/-, and the amount shall be adjusted to P.D. A/c.No.GA-77 of Andhra Pradesh State Handloom Weavers' Co-operative Society Limited (APCO), and disburse the amount to the concerned.

5. In the reference 6th read above, the Commissioner of Handlooms, Textiles & Apparel Export Parks, Hyderabad was informed that in the references 4th and 5th read above, it was made clear that 100% of the Outstanding Principal will be reimbursed by the State Government in tune with the One Time Settlement (OTS) of the Banks and the amount of Rs.16,67,95,443/- which was released had to be disbursed to the Banks on the basis of 100% reimbursement. The Commissioner of Handlooms, Textiles & Apparel Export Parks, Hyderabad was requested to follow these instructions and to disburse 100% to the banks so as to get No Due Certificate. If still further amounts are required, he was also requested to send necessary proposals to the Government for further orders.

6. In the reference 7th read above, the Commissioner of Handlooms and Textiles and Commissioner for Apparel Export Parks, Andhra Pradesh, Hyderabad has stated that an amount of Rs.16,67,74,691/- was released towards waiver of 100% Principal outstanding as on 31-03-2010 against individual loans of Handloom Weavers under Artisan Credit Card (A.C.C.) / Prime Minister's Rozgar Yojana (PMRY) / Rajiv Yuva Shakti (RYS) payable to the respective Commercial and other Banks leaving a balance of Rs.20,752/-. Further, an amount of Rs.5,56,20,089/- is required for settlement of balance claims of the following Districts to ensure 100% payment of outstanding dues to Commercial and other Banks:-

Since a balance amount of Rs.20,752/- is available as un-disbursed, a sum of Rs.5,55,99,337/- is only required to settle the claims of above (5) Districts, as detailed below:-

7. The Commissioner of Handlooms, Textiles & Apparel Export Parks, Hyderabad has further stated that a sum of Rs.200.00 crores were allocated in the Budget Estimates for the Financial Year 2011-12, under the Head of Account SH(12) - Assistance towards Loan Waiver to Weavers. The Commissioner of Handlooms, Textiles & Apparel Export Parks, Hyderabad has requested the Government to sanction an amount of Rs.5,55,99,337/- to settle the claims of (5) Districts viz., Visakhapatnam, Guntur, Chittoor, Kadapa, Kurnool, towards balance amount of 100% waiver of Individual Loans (ACC/PMRY/RYS), so as to obtain "No Due Certificate" from the Banks in respect of 11651 individual weaver beneficiaries.

8. After careful examination, Government have decided to sanction an amount of Rs. 5,55,99,337 (Rupees Five Crores, Fifty Five lakhs, Ninty Nine Thousand and Three Hundred and Thirty Seven only) to settle the claims of 25% of balance amount of waiver of Individual Loans (ACC/PMRY/RYS) in respect of (5) Districts viz., Visakhapatnam, Guntur, Chittoor, Kadapa and Kurnool, so as to obtain "No Due Certificate" from the Banks in respect of 11651 individual weaver beneficiaries.

9. Accordingly and as per the Budget Release Order issued by the Finance (Exp.I&C) Department in the reference 8th read above, the Government hereby accord sanction for an amount of Rs.5,55,99,337 (Rupees Five Crores, Fifty Five lakhs, Ninty Nine Thousand and Three Hundred and Thirty Seven only) to settle the claims of 25% of balance amount of waiver of Individual Loans (ACC/PMRY/RYS) in respect of (5) Districts viz., Visakhapatnam, Guntur, Chittoor, Kadapa and Kurnool, so as to obtain "No Due Certificate" from the Banks in respect of 11651 individual weaver beneficiaries.
