O R D E R:-

In the reference 1<sup>st</sup> read above, Government have issued orders appointing the Assistant Directors who are having jurisdiction of the respective Cooperative Spinning mills as Managing Directors (I/c) for the (4) Cooperative Spinning Mills Viz., 1) Rajahmundry Co-operative Spinning Mills Ltd. Rajahmundry (2) Nellore Co-operative Spinning Mills Ltd., Nellore (3) The Parchur Cotton Growers Co-operative Spinning Mills Ltd. Inkollu (4) Adilabad Cotton Growers Co-operative Spinning Mills Ltd., Adilabad to manage the affairs of the concerned Cooperative Spinning Mills.

2. In the reference 2<sup>nd</sup> read above, the Director of Handlooms & Textiles and Apparel Export Parks, A.P. Hyderabad has requested the Government to issue orders for winding up of the affairs of the (4) Cooperative Spinning Mills under Section 64 of the Andhra Pradesh Co-operative Societies Act, 1964 Act and to appoint the officers indicated against each as Liquidators to the following four (4) Cooperative Spinning Mills under section 65 of the Andhra Pradesh Co-operative Societies Act, 1964 Act read with rule 51 of the APCS Act 1964 for a period of two (2) years from the date of assumption of charge as Liquidator or till the liquidation process is completed, which ever is earlier, while exercising powers vested under section 123 of APCS Act 1964. The Liquidators shall discharge all the liabilities of the Mill strictly in the order of priority set out under Section 12(A) (9) of APCS Act 7 of 1964 and close or dissolve the Mills duly following the procedure as laid down in the APCS Act, 1964:-
